#### CC464 - MINUTES OF MEETING HELD ON 18 JANUARY 2017

#### **CC465 - POLICE MATTERS**

PC Steven Graham presented the police report:

- Further reports of egg throwing at houses. Police spoke to children thought to be involved and gave suitable advice. Incidents have now ceased.
- Complaint of noisy youths after birthday party on 28 January. Situation monitored.
- Inconsiderate parking in vicinity of Primary School. One driver reported to Procurator Fiscal on 25 January for parking on zig zag lines outside school.
- Speed checks carried out. Two drivers issued with conditional offers of fixed penalties.
- On 17 January, driver arrested for drink driving.
- Road traffic accident on 29 January on A81 near to distillery. Damage to telegraph pole but driver not injured.
- On 19 January between 8.00 am and 6.15 pm, house in Elder Road broken into by forcing rear patio door. House ransacked and electrical equipment and jewellery stolen. Enquiries are still ongoing. Members of the public were urged to contact police with any information felt to be of assistance.

- No feedback from SC re blocked drains on Station Road.
- Following positive meeting with SC Roads Dept staff and KCC members on 30 January, KCC have undertaken a pavement survey of the whole village.
   Findings will be presented to SC and followed by a site visit on 27 February when SC will see the worst pavement areas in Killearn. It is hoped that, as a result, finance will be allocated to Killearn for necessary repairs.
