CC850 - MINUTES OF MEETING HELD ON 18 SEPTEMBER 2019

The minutes were accepted as a true record of the meeting.

CC851 – POLICE MATTERS

As the Police were unable to attend the meeting, Fiona presented the following report:

- Youths causing noise disturbance at Primary School at the weekends.
- Damage caused to a school bench in Primary School playground. Three persons identified, traced and charged in relation to Vandalism.
- Police to give extra attention to Primary School in coming months.
- Continued issues re parking and roads blocked at Finnich Toll.
- Numerous reports of deer and trees on roads around the village.
- Minor road traffic collision in Killearn.
- Theft of motor vehicle from outlying work premises. Scaffolding was stolen on the same night and police are continuing enquiries.
- Ongoing enquiries into theft of timber for flooring from outskirts of Killearn.
- Alarm activations at residential properties are always attended by police to verify all in order.
- Extra attention provided in the village by local officers through evenings and nights.
- Suspicious vehicle in Killearn reported. Police attended immediately and all appeared to be in order.

Other Planning Issues

The meeting was informed that due to remediation costs at Killearn Hospital site being higher than anticipated, CALA Homes wish to undertake further work to assess the viability of the site for development.

CC855 - ROADS AND GENERAL MAINTENANCE REPORT

Branziert Road North closed from 27 October – 12 November for resurfacing works.

A875 closed from Dunmore Street, Balfron to Boquhan from 21 October – 1 November, 8.00 am - 6.00 pm, for resurfacing works.

Station Road may be closed on 2 November from 6.00 pm during Fireworks Display.

It was agreed KCC organise a further walk around the village to update the list of road/pavement priorities and to identify problems such as blocked gulleys, drains, etc. Residents are encouraged to report any issues to KCC.

CC856 - COUNCILLOR'S REPORT

Cllr Lambie highlighted the following points in his report:

- Your Stirling You Decide results pedestrian crossing and speed restrictions on Main Street, Buchlyvie and Arnprior playpark activity pavilion.
- Serious concerns about First Bus changes to provision in rural Stirlingshire.
- Planning application for development at Finnich Glen.
- Possibility of increased number of houses on Killearn Hospital site.
- Recommendation of Main Street pedestrian crossing (puffin type).
- Birch Road dropped kerb location.
- Former Killearn Hotel proposals. No objections received.
- Local road closures.
- Blanewater Bridge repair completed.
- Road Maintenance Programme 2019.

Subsequent comments and questions from members of the public were raised:

- Need for hedge cutting at entrance to Co-op car park, junction at Station Rd/ Endrick Road and at Station Road/Napier Road to enable drivers to see clearly.
- Report of dangerous pot hole on Ballochruin Road.
- Flooding problems in Park where new play equipment is being installed. It was agreed KCC alert SC to the situation.
- Request for extension to double yellow lines at top of Station Road at narrowest point as parked cars make it difficult to see oncoming traffic and negotiate this part of the road safely.
- Concern was expressed about difficulty for traffic crossing Blane Bridge and the
 need for priority signage to be reversed. It was also noted that hedging requires to
 be cut back to improve visibility. In the light of increased traffic expected from the
 development at the Killearn Hospital site and the proposed Finnich Glenn visitors'
 centre, it was agreed longer term planning for the bridge should be considered.
- Request for improvement to the appearance of roundabout on A81 approach to Killearn.

KCC agreed to contact appropriate SC departments regarding these issues. (Action JP/FR)
