Other Planning Matters

Development of Former Killearn Hotel

SC Planning Officer has not yet approved the proposals as he needs to be convinced of the requirement to demolish the building. He is also concerned about the impact on the Conservation Area by moving it back by 2m. The developer and SC are in discussion about this and further information will be available once a decision has been made.

It was noted that KCC has previously supported these aspects of the application and are happy to respond to the Planning Officer as required.

Rural Stirling Housing Association – Lampson Road site

RSHA are progressing with their application which is still to be submitted. They have identified potential tenants for the new houses.

Former Killearn Hospital Site

Cala have submitted their application for developing the site. It was noted that some excavation work has taken place recently and Jim has written to SEPA and SC regarding the demolition and removal of material from what is understood to be a contaminated site. It was agreed Jim request an update on the situation from SC Department of Health and Safety. (Action JP)

Cowfield

There are no longer any sheep in the field but it was noted that some of the works agreed to replace access gates etc have not yet been completed. It was agreed Fiona query this with Angela Simpson of SC. (Action FR)

Jim informed the meeting that some local residents are considering approaching the landowner and farmer to discuss an option for a community purchase or lease of some of this land.

SC has repaired a small raised drain cover on Main Street near junction with Ibert Road.
