#### **CC342 - POLICE MATTERS**

PC Steven Graham informed the meeting of the following:

- Drunken, noisy youths caused a disturbance near the school on evening of 24 March.
- Damage to window in Main Street by stone throwing in early hours of 25 March.
- Damage to fence within the school by group of youths on 5 April.
- Complaint of noisy party in Harpers Road on 9 April.
- Two drivers caught speeding on Station Road. One driver reported to Procurator Fiscal for speeding at 52 mph.
- One driver caught speeding at Dumgoyne.
- Accident on A81 near Glengoyne Distillery on 16 April after vehicle skidded on black ice. No injury was sustained.
- Between 26 and 28 March, theft of conifer in large plant pot from house in Main Street.

# CC343 - BLAIRESSAN DEVELOPMENT

Following the public consultation event on Tuesday 29 March 2016 by developers Mactaggart and Mickel, Margaret informed the meeting of comments she and other members of KCC had received regarding the proposed development at Blairessan. These included:

- 1. 120 people attended the event. Leaflets were distributed to only 200 households.
- 2. Concern expressed over plan showing 33 instead of allocated 30 houses.
- 3. Fibre to the premises (FTTP) broadband provision to new houses.
- 4. Majority of comments expressed too many 4-5 bed houses proposed.
- 5. Houses with two upper floors are too high for the site.
- 6. Need for smaller houses to buy as well as rent e.g. bungalows, flats, terraced and semis to enable elderly residents to downsize, and young people to buy.
- 7. More information on social houses to rent, managed by Rural Stirling Housing Association, is awaited.
- 8. House styles to be more in keeping with adjacent Conservation Area.
- 9. Houses should be spaced out more, using whole area.

- 10. Many comments disliked shared vehicle and pedestrian space. Unanimous preference for payements and safe areas for children to play.
- 11. More parking provision required.
- 12. Concern re new houses overlooking or taking light from existing properties.
- 13. Drainage of site.
- 14. Additional traffic on Station Road will be a major problem.
- 15. Safe crossing point on Station Road for pedestrians required.
- 16. Pavements need to be provided on Station Road.
- 17. Many comments against roundabout giving access to the site from Station Road.
- 18. Consideration should be given to access from Drumtian Road.
- 19. Loss of parking places on Station Road will create more problems.
- 20. Landscaping and boundary issues.
